M-370 A is a water-based additive to alkaline fluids and is specially formulated to protect aluminum. Solutions containing M-370 A remain stable and clear. This additive does not contain nitrites, phosphates, silicates or chromates and is based on Cortec's VCI (Vapor Corrosion Inhibitor) technology.

M-370 A is available in 5 gallon (19 liter) pails, 55 gallon (208 liter) drums, totes and bulk. M-370 A should be stored in tightly sealed containers of metal, glass or polyolefin plastic at temperatures above 32°F (0°C). Maximum storage temperature is 120°F (50°C).
